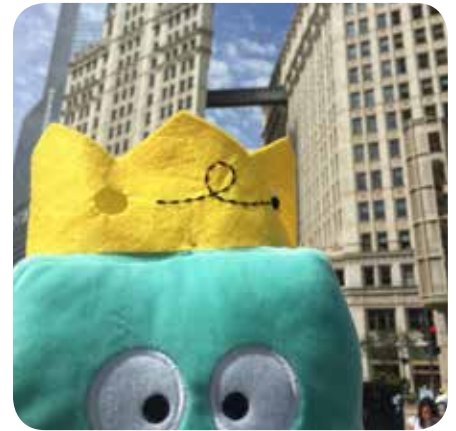

Speak Up for Patient Health: Critical Conversations on Controversial Issues PD, DT

“The topic is important, but I don’t know what to say!” Pediatric dental professionals find it challenging to talk with parents and patients (especially adolescents) about a host of medical conditions and lifestyle choices related to oral health. This interactive session offers practical advice from top content experts on how to hold effective conversations on such difficult topics as overweight/obesity, eating disorders, substance use, transgender issues, sexual practices, pregnancy and STIs. It tells how to break bad news in the face of unexpected treatment results – and mistakes. The session will boost communication skills and confidence for pediatric dentists and team members when addressing topics that might make parents and adolescent patients feel embarrassed, upset, judged negatively, or unwilling to return to your practice.

Communication is a must have skill for pediatric dentistry, especially when the discussion turns difficult or the only response from a ‘tween patient is a shrug or eye roll. It is critical to oral health literacy, informed consent, patient motivation and behavior change. In addition, strong communication skills bring many benefits. Patients who have positive communication with their health providers are more likely to accept treatment recommendations, have less anxiety about treatment, experience less discomfort, require less medication and recuperate more quickly than patients who do not. A fast-paced session relevant for every member of the pediatric dental team

100. Precision Medicine

Peter Polverini, D.D.S., D.M.Sc.

Precision medicine is an approach to disease prevention and treatment that considers genetic variability, and environmental and lifestyle influences that are unique to each patient. It facilitates stratification of patient populations that vary in their susceptibility to disease and response to therapy. It is a strategy that uses the unique genomic and biological characteristics of a patient to identify treatment specific targets. Analysis of the genome and unique molecular profile of patients with chronic diseases has revealed new, potentially actionable therapeutic targets. Precision medicine has been shown to be an increasingly successful approach to cancer therapy. Biomarkers enable target specific treatments that are more reliable in predicting response to treatment and result in better health outcomes. Recent successes in the use of immunity-inducing antibodies have stimulated increased interest in the use of precision immunotherapy of cancer. Continued interrogation of the human genome will reveal new actionable targets for patients with chronic diseases resulting in improved therapeutic efficacy. The application of the principals of precision health and medicine in dentistry will dramatically alter dental education and dental practice.

- Understand how Precision Medicine improves upon our current approach to health care
- Understand how a patient's genomic information and biochemical fingerprint is used in disease prevention, risk assessment and to mitigate the course of chronic disease
- Understand the impact of Precision Medicine on dental education and practice



POLVERINI

Dr. Peter Polverini is the Jonathan Taft Distinguished University Professor of Dentistry and dean emeritus, University of Michigan Dental School and Professor of Pathology, University of Michigan Medical School. Polverini holds a bachelor's degree in biology and a D.D.S. from Marquette University. He completed specialty training in Oral and Maxillofacial Pathology at the Harvard School of Dental Medicine and was awarded the Doctor of Medical Sciences degree from Harvard University. Polverini has a distinguished scientific career in the field of vascular and cancer biology where he has long been a leader and influential figure. More recently, he has focused his attention on identifying the mechanisms responsible for the progression of oral epithelial dysplasias and strategies for integrating precision medicine into dental practice. He is considered an accomplished mentor, scholar, motivator and seasoned administrator who has fostered innovation in dental education by promoting scholarship and scientific rigor. Polverini is a Diplomat of the American Board of Oral and Maxillofacial Pathology, Fellow of the American Academy of Oral and Maxillofacial Pathology, a recipient of the Distinguished Scientist Award

in Oral Medicine and Pathology from the International Association for Dental Research and the Birnberg Award for Excellence in Dental Research from Columbia University College of Dental Medicine. He was the recipient of the Distinguished Alumnus Award from the Marquette University School of Dentistry and the Harvard School of Dental Medicine and the William J Gies Award for Vision by a Dental Educator from the American Dental Education Association Gies Foundation. Polverini is a Fellow of the American Association for the Advancement of Sciences, past President of the American Association for Dental Research and former Health Policy Fellow with the University of Michigan Center for Healthcare Research and Transformation. Polverini is an elected member of the National Academy of Medicine.

110. New Parents and Toothy Toddlers: Practical Strategies to Prevent/Manage Caries in Young Patients PD, DT

Francisco Ramos Gomez, D.D.S., M.S., M.P.H.; Man Wai Ng D.D.S., M.P.H.

This course will focus on training pediatric, general dentists, and their team on how to deal with the young child in their dental practice; how to incorporate the AAPD's six steps of infant oral care; and the rationale and impact of implementing a structured Caries Management by Risk Assessment (CAMBRA) protocol in their practice in order to improve children's oral health outcomes.

In general, there is an increasing trend toward providing dental care to children before the age of three. The American Academy of Pediatric Dentistry (AAPD) and the American Association of Pediatrics (AAP) currently recommend that children receive their first dental evaluation within the first year of life, a recommendation that has been in place with the AAPD for 25 years. The age one visit allows for early dental intervention with infants and their parents or caregivers to determine a risk status based on a parental interview. Dentists are able to perform a screening risk assessment and examination of infants' mouths and early care provides an opportunity to educate and inform parents about their children's oral health. Anticipatory guidance/counseling for children's dental health is an important part of preventive care, and may be the most effective way to prevent problems that traditional infectious-disease surgical models have failed to address, such as early childhood caries (ECC). The use of combination therapy of anti-bacterials and other remineralizing treatments like fluoride varnish applied and when added to caregiver counseling (anticipatory guidance/self-management goals), has proven to be effective prevention strategies in reducing ECC incidence in young children. Fluoride varnish efficacy in combination in this age group provides additional rationale for an early dental visit, especially for children in high caries-risk groups. The model of anticipatory care guidance and cultural self-management is valuable for general dentists and dental auxiliaries because its em-

phasis is preventive rather than restorative care. A comprehensive infant oral care program utilizes 1) a caries risk assessment, 2) proper knee-to-knee positioning, 3) a toothbrush prophylaxis, 4) a dental exam, 5) fluoride varnish, and 6) anticipatory guidance/SMG. Facilitating access to early and regular dental care is a crucial part of any effective intervention strategy, and intervention techniques should be tailored to the community being served. We will also address the fears of dental providers dealing with young crying children in their practices and make them familiar with Infants and toddlers and common behaviors in their practice.

Upon completion of this course, attendees will be able to:

- Learn how dentists, dental hygienists, dental assistants can establish a team and protocols to provide an oral health risk assessment, dental exam, prevention care-paths, self-management goals with caregivers for their infants, and establish a Dental Home for young children
- Learn to examine, diagnose, and treat very young children using an Infant Oral Care model
- Become familiar with the latest background and evidence-based protocols of risk assessment, infant oral care, and treatment options for children 0-2 and 3-5 years old



RAMOS-GOMES

Dr. Ramos-Gomez is a professor in the UCLA Section of Pediatric Dentistry and the director for the Pediatric Dentistry Advanced Clinical Trainees Program. Ramos-Gomez joined UCLA as a faculty member in 2008. Ramos-Gomez has over 30 years of experience in pediatric oral health and has worked on numerous community projects over the past 25 years.

He has authored well over 60 articles on pediatric and community oral health. He also holds a Masters of Public Health degree from Harvard University School of Public Health. In 2010, UCLA Pediatric Dentistry, under the direction of Ramos-Gomez, launched an Infant Oral Care Program (IOCP) at the local community clinic. The Infant Oral Care Program is part of a large multi-state quality improvement Early Childhood Caries Collaborative. It provides care coordination that is culturally competent, sensitive to language and oral health literacy challenges. The program aims to increase access to care and improve oral health outcomes through a disease prevention and management model (CAMBRA) targeted at typically underserved, low-income, minority children ages 0-5 and their mothers/caregivers in a non-traditional setting. He also conceptualized and founded the UCLA Center for Children's Oral Health (www.uccoh.org). The mission of UCCOH is to reduce oral health morbidity for underserved and minority children through the utilization of interprofessional partnerships and expansion of preventive oral health education and care for vulnerable populations. Through the delivery of preventive oral health education, systems change approach, identification of best evidence-based research to provide affordable quality preventive oral health care, utilization of innovative training curricula, and leadership of policy and advocacy development efforts, UCCOH aims to create a paradigm shift within the landscape of pediatric dental care from reactive to proactive.

Dr. Man Wai Ng is chief of Dentistry at Boston Children’s Hospital and Associate Professor of Developmental Biology (Pediatric Dentistry) at the Harvard School of Dental Medicine. A former member of the American Academy of Pediatric Dentistry board of trustees, she is a board-certified pediatric dentist who is currently serving as a director of the American Board

of Pediatric Dentistry. She has been principal investigator on an Early Childhood Caries Disease Management Collaborative that has been focused on effective engagement and communication with parents to improve their children’s oral health.

140. Advanced Pediatric Dentistry: Building Your Confidence for Challenging Cases PD

Success in pediatric dentistry requires that we develop the skills necessary to meet the everyday demands we face as pediatric dentists. Caries is the disease we are trained to prevent and treat and as we grow as practitioners, we each face the same daunting questions and challenges in trying to meet the needs of our patients. This is an exciting time for dentistry as advances in dental materials, and diagnostic technology is changing and creating new paradigms for caries treatment and prevention. This course will present some of the most challenging cases and scenarios we face as pediatric dentists. A detailed discussion and case presentation will highlight both mistakes and solutions on topics ranging from complicated restorative, acid erosion, eruption problems, periodontal diseases, trauma, pulp therapy, interceptive orthodontics, and CAD/CAM. At the end of the course, attendees will have a core set of practice scenarios, and treatment plans, they can use to implement any of the concepts presented in this course. It is the goal of this course to provide the participants with a lively discussion and presentation regarding the latest concepts in varying aspects of pediatric dentistry.

Upon completion, attendees will be able to:

- Better approach complicated patients to develop a prioritized treatment plan based upon updated techniques and research to help them achieve predictable results
- Discuss various caries patterns, interpret updated concepts about cariology, and apply this information to treatment planning and prevention

Dr. Martha Ann Keels received her dental degree from the University of North Carolina, Chapel Hill in 1984. In 1990, she received a certificate of pediatric dentistry from the University of North Carolina, where she also completed her Ph.D. in Epidemiology in 1991. In 1991, she established the Pediatric Dental program at Duke University Medical Center. She currently is the division chief of Pediatric

Dentistry at Duke Children's Hospital. She is also board certified by the American Board of Pediatric Dentistry (ABPD) and serves on the Examining Committee for the ABPD. Keels holds fellowships in the American Academy of Pediatric Dentistry, American College of Dentists, the International College of Dentists, and is a member of several national and international associations and societies. In 1984 she was elected to membership in OKU (dental honor society). She has served as president of the North Carolina Academy of Pediatric Dentistry; on the editorial board of Pediatric Dentistry; and on the Council for Clinical Affairs for the American Academy of Pediatric Dentistry. She served as the chair of the Section of Pediatric Dentistry and Oral Health within the American Academy of Pediatrics from 2004-2010. She was the recipient of the NIH Dentist-Scientist Award, which funded specialty training in Pediatric Dentistry and Ph.D. training in Epidemiology at the University of North Carolina. Keels has received recognitions for her research efforts as a Pfeiffer Foundation Research Fellow and has been awarded the Quintessence Award for Research Achievement and the Derek Turner Postdoctoral Research Award in Clinical Sciences. She received NIH funding for an epidemiological study of water fluoridation from 1997-2001; currently, she continues her research in dental caries risk factor analysis and dental acid erosion in pediatric patients.



SLONKOSKY

Dr. Philip Slonkosky is a licensed, board-certified pediatric dentist, business owner, practice strategist, and amateur podcaster. He received his D.M.D. degree from the University of Louisville, and M.S. and pediatric certificate from the University of Kentucky in 2009. He is the co-founder of Pediatric Dental Directions (a pediatric dental consulting/coaching company), co-owner of Minster Dental Care, and co-founder of Integrative Health Supplements, a new family business he is starting with his brothers. As a practitioner of pediatric dentistry for over 9 years, Slonkosky continues to push the profession forward by integrating emerging medical science with the latest technology dentistry has to offer. He seeks to understand the underlying and often multifactorial causes of dental disease. For the last few years Slonkosky has focused on ways to help educate his patients and community about the underlying causes of oral disease and its relationship to overall health. As a practice, Minster Dental Care, has grown from a three doctor practice with 15 team members, to now include six doctors, and over 35 team members. A new specialty wing was completed at the start of 2018, allow the facility to grow into a much needed space. Since 2014, Slonkosky has given numerous presentation and lectures with Dr. Elliott, Dr. Keels and their friends focusing on customer services, TEAM leadership, advanced clinical treatment planning. In 2018 he released his first podcast, The PDDx Experience. A podcast series focusing on anything and everything related to pediatric dentistry.

150. Everything the Pediatric Dentist Ever Needed to Know about Kids with Concussion and ADHD

Children with neurological disorders can present in any healthcare setting, including the pediatric dentist. Knowledge and preparation to respond is important. This presentation will address the issues that the clinician might face when working with children presenting with the common neurological conditions, Attention-Deficit/Hyperactivity Disorder and Concussion. This session will review typical brain development and our current understanding of these disorders underlying dysfunction, including pathophysiology, signs and symptoms, and key manifestations in everyday environments. Strategies for management of these disorders will be discussed. A better understanding of concussions and ADHD will lead to more effective management of these children in practice.

Upon completion, participants will be able to:

- Articulate 3 key factors that underlie normal brain development
- Define ADHD and concussion including signs and symptoms and underlying neuropathophysiology
- Identify ways to screen and manage patients with these disorders in your practice, and provide effective dental services



GIOIA

Dr. Gerard Gioia is the division chief of Pediatric Neuropsychology at Children's National Health System, where he directs the SCORE Concussion Program. He is professor of Pediatrics and Psychiatry at the GWU School of Medicine. He is an active clinician who has evaluated and treated children with a variety of neurological disorders from infancy to young

adulthood. As a researcher, in addition to developing clinical tools, he has studied outcomes of mild TBI and a variety of other developmental and acquired neurologic disorders in children. He works actively with the CDC on a number of initiatives including their "Heads Up" concussion educational toolkits. Gioia has participated in the International Concussion in Sport Group Consensus meetings, American Academy of Neurology Sports Concussion Guideline panel, NIH's Common Data Elements for mild TBI/sports concussion, and the CDC's mild TBI guideline development. He worked on a number of legislative activities, locally and nationally over the past ten years. As a sports neuropsychologist, he serves the Washington Capitals, Baltimore Ravens, and a host of universities, school systems, and youth sports organizations. He is the incoming president of the Sports Neuropsychology Society. Finally, he is the father of three and a grandfather of three.

ESSLING

Mary Essling is dental benefits director for the American Academy of Pediatric Dentistry. Essling has previous experience working on dental and medical procedure coding and third-party insurance matters for both the American Dental Association (from 1994 - 2002) and the American Society of Plastic Surgeons. She earned her Bachelor of Science degree from

Marquette University and an M.S. in Health Law Policy from DePaul University. In addition, Essling is a licensed registered dental hygienist in Illinois, Indiana and Texas.



TUINEI

Mr. Ben Tuinei began his dental career in 2007 while working for 10 location group practice in Phoenix, Ariz., managing all insurance related functions. During his first few months, he created systems and operating protocols and restructured a 12-person billing department that improved collections from a low 65 percent to 98 percent. At the same time, Tuinei learned

how to effectively negotiate with 3rd party payors that gave a boost in annual insurance related revenue of nearly 1 million dollars for a team of only 10 general dentists. Tuinei's early experience in negotiating with 3rd party payors caught the attention of other large group practices and hundreds of solo dental practitioners in Arizona, Utah, Nevada, Idaho and Colorado. Consequently, he unintentionally discovered an under-served section of the dental industry: 3rd party payor negotiating (aka insurance fee negotiating). Tuinei opened Optimum Dental Solutions in September 2009 and rebranded to Veritas Dental Resources in 2015.



FINKELSTEIN

Dr. Allen Finkelstein, the chief executive officer of Bedford HealthCare Solutions is the former chief dental officer of AmeriChoice/ United Health Group insuring over 3.5 million lives in dental government coverage. Finkelstein is currently an adjunct clinical assistant professor of Pediatric Dentistry at New York University, College of Dentistry, Senior Advisor for Oral

Health Strategies adjunct faculty member of the Arizona School of Dentistry and Oral Health AT Still University, a member of the Harvard University School of Dental Medicine Dean's Advisory Board, a member of Drexel College of Medicine Student Advisory Board, a member of the Visitor's Board of the Kornberg School of Dentistry at Temple University, a member of the

260. Aesthetics – Bleaching and Acid Abrasion PD, DT

A child’s smile and the appearance of their teeth are strongly associated with their self- image and feeling of well-being. Dental defects that affect the esthetics of the primary and/or permanent dentitions are caused by a variety of environmental and genetic factors. The number of teeth involved can vary and the severity can range from mild to severe depending on the etiology of the discoloration. Pediatric dentists are uniquely positioned to diagnose and manage esthetic dental issues in the primary and early permanent dentitions. Approaches directed at improving dental esthetics can involve a variety of techniques including vital and non-vital bleaching, microabrasion, etch-bleach-seal, resin perfusion, combination therapies, and restorative therapy. This course will review the more common esthetic dental concerns seen in pediatric patients and present the different techniques used in the dental office to manage them.

- Describe the diverse etiologies and clinical appearances of conditions associated with dental discolorations and their potential impact on esthetics and an affected individual’s self-image

270. Obstructive Sleep Apnea in Children PD

Obstructive sleep apnea syndrome (OSAS) in children is defined as a “disorder of breathing during sleep characterized by prolonged partial upper airway obstruction and/or intermittent complete obstruction that disrupts normal ventilation during sleep and normal sleep patterns.” OSAS is both prevalent and underdiagnosed in children. OSAS has harmful central nervous system, cardiovascular, and metabolic consequences, which can include an inability to concentrate in school, poor academic performance, behavioral problems, cardiovascular effects, and poor growth and development. Apneas in children are produced by an imbalance between upper airway load and neuromuscular tone. Many factors influence these attributes, but the most important are adenotonsillar hypertrophy and obesity. History and examination are fundamental areas that dentists can use to help diagnose OSAS in pediatric patients. Full-night polysomnography is the gold standard for obtaining a definitive diagnosis. Dental practitioners also can play a crucial role in the treatment and management of this condition.

- Summarize the signs and symptoms of a child that presents with Obstructive Sleep Apnea in the dental setting
- Name the harmful consequences of Obstructive Sleep Apnea in children

Dr. Jonathan Bacon, Howard University College of Dentistry

Dr. Jonathan Bacon is a Diplomate of the American Board of Pediatric Dentistry and has always been interested in education. His mother sparked this interest at an early age. She taught special education for over 30 years and was extremely respected within her field. She inspired him to always give back to those who are less fortunate. Accordingly, in high school he worked

as an instructional assistant for special needs children. Following college, he continued to pursue education and worked as a high school teacher for Spanish and biology before eventually deciding to pursue a career in dentistry.

He works as an educator for pediatric and OMFS residents and plans to provide anesthesia services at Howard University Hospital in the near future.

During his five years of post-doctoral training, Bacon accrued interest on his student loans and accepted a significant loss in salary. However, the HRSA grant has alleviated this financial burden and made it possible for him to return to education. He hopes to utilize his foundation in anesthesia to improve access to care for special needs patients and children of all ages. He seeks to improve resident learning through novel educational approaches and wishes to inspire the future dentists of tomorrow.

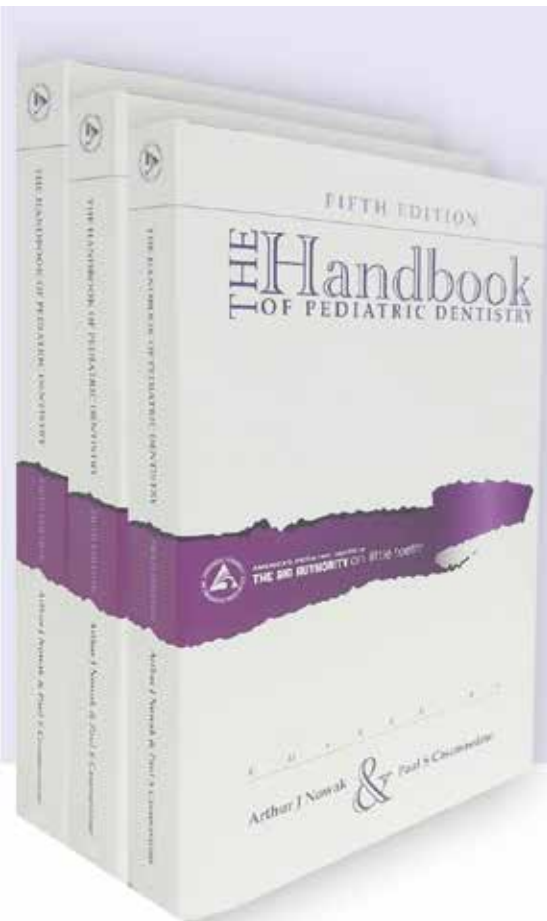

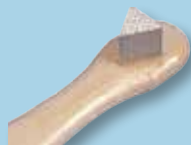

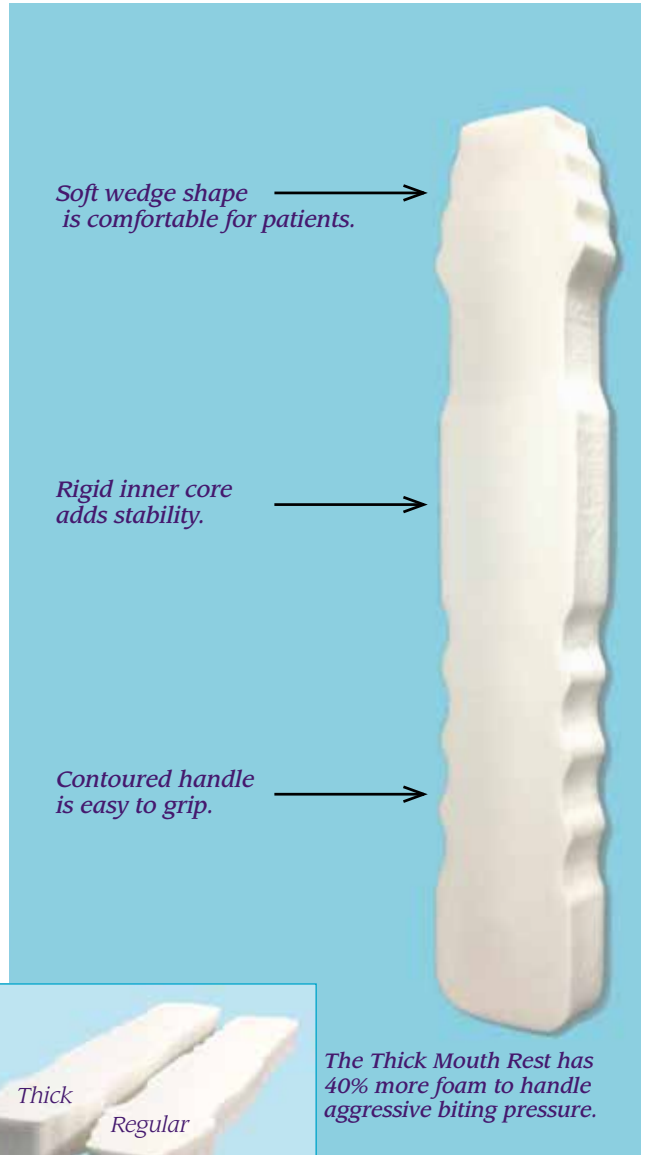
